Consistent with Christ's pattern and that of His prophets, anyone fitting scripture's model for prophetic ministry should expect no more than a 10-12% margin of error or diminished effectivity rate as a full time prophet. Any greater ineffectivity leeway would compromise the integrity of the office, reduce its precision, and counteract its credibility. Besides being biblically sound according to scripture's model of excellence for this office, the PAQ's acceptable margin of error somewhat correlates with the actions of people in other professions who discharge a comparable office. Your Prophetic Mantleship

The prophet's mantle is the minister's source of power, performance, and economy. It is the individualized resource the Lord uses to actuate the wearer's latent gifts and talents for His divine communications use. Think of your prophet's mantle as your uniform of service. It expresses your natural proclivities for the office, most notably your personal aptitudes. Your prophetic mantleship exudes your most detectable spiritual and ministerial adornments. It reflects your divinely designated rank and reveals to your peers and colleagues your level of professionalism, authority, and most consistent effects.
