

GetResponse PPC FTNU Promotion Terms and Conditions

I. About the promotion

- 1. These terms and conditions relate to the GetResponse Discount For Free Trial Users (we'll call it "the promotion" from now on).
- 2. The promotion is run by GetResponse S.A. Our company is incorporated under the laws of Poland, with our registered office at Aleja Grunwaldzka 413, 80-309 Gdansk, Poland, registered at the National Court Register at Company No. (KRS) 0000942075, NIP No. 9581468984, REGON No. 192998251, with a share capital of PLN 5 559 840 fully paid (we'll say "GetResponse", "us", or "our" from now on).
- 3. By taking part in our promotion, you accept these terms and conditions.

II. Taking part

- 1. The promotion is open to users of free GetResponse accounts ("Participant/s"). The promotion is not available to current users of paid GetResponse accounts.
- 2. To participate in the promotion, you need to upgrade your free account to a paid account using the PPCFTNU10 coupon code within the promotional period, which starts on April 19, 2023 and ends on June 15, 2023 ("promotion term").

III. Promotion rules

- 1. The promotion refers to the following GetResponse products or services: 12-month plan of our Email Marketing, Marketing Automation or Ecommerce Marketing account package (Account").
- 2. The promotion entitles you to use the Account at 10 % off the regular price throughout the entire term of the contract ("Discount"). You can view the standard pricing here: https://www.getresponse.com/pricing.
- 3. The Discount refers only to standard features of the chosen product or service. Additional features remain at the regular price.
- 4. You can only buy one Account with 12-month subscription plan at the given Discount.
- 5. The Discount combines with our regular 18% annual pre-pay discount. The annual discount is applied to the amount discounted by the initial 10% which amounts to the final discount of 28% on the annual pre-pay plans.
- 6. Subject to Section 5 above, the Discount cannot be combined with other GetResponse promotions available during the promotion term or otherwise.
- 7. If you make any changes to the Account bought during the promotion term, such as the subscription plan or period, or the Account is deactivated for any reason, we'll forfeit the Discount, and it won't be reinstated.
- 8. You can't transfer your Discount to anyone else or apply it to an existing GetResponse account.
