





Privacy Information Notice

Herewith, Huawei Tecnologies Italia S.r.l. ("Huawei" or the "Company"), in accordance with the provisions of the European General Data Protection Regulation no. 679/2016 (hereinafter "GDPR") and with the Code regarding the protection of personal data (Legislative Decree no. 196/2003, as amended), would like to inform you that your Personal Data collected during the Tech Arena event organized from 1st of August to 30th of November 2024 on-line on the website dedicated to the Event and at the seat of Huawei (hereinafter, "Event"), will be processed by this Company in full compliance with current legislation and in accordance with the following information.

1. HOW HUAWEI USES YOUR PERSONAL DATA AND FOR WHAT PURPOSE

Categories of personal data subject to processing, purposes and methods.

The Personal Data subject to processing consist, by way of example and without limitation, the name and surname, school / university, images, video recordings, and other information that Huawei has lawfully acquired during the Event and that identifies or makes identifiable a natural person under the GDPR ("Personal Data").

Huawei will process Personal Data such as name, surname, personal data relating to the school/university to which you belong and the course of your studies, including Images as defined in the Disclaimer for the Use of Images defined for the Event.

Purpose and legal basis of the processing of Personal Data

Huawei will process Personal Data during the Event for the following purposes:

- comply with provisions of laws and regulations, or execute an order of Judicial Authority or Supervisory Authority;
- for participation in the Event, the registration to the Event requested by you, including all activities, before and after the Event, that are instrumental to the organization of the same (e.g. confirmation of Event registration, sending of service communications and Event reminders).
- the processing, dissemination and reproduction of Personal Data (including Images) through Huawei's social media channels and on the website dedicated to the Event by Tree S.r.l. for the purpose of promoting the Event and, more generally, the Company;
- with your consent, to receive invitations related to future events organized by Huawei.

The processing of data for the purposes sub a) does not require your consent pursuant to art. 6 para. 1 lit. b) c) f) of the GDPR.

The processing of data for the purposes sub b) - d) requires your consent pursuant to art. 6 para. 1 lit. a) of the GDPR. Failure to provide Personal Data will have the sole consequence of not being able to achieve the aforementioned purposes.

2. METHOD OF PROCESSING

The processing carried out will always be based on the principles of minimization, purpose limitation, accuracy, lawfulness and transparency and protection of the privacy and rights of the data subjects. When processing Personal Data, the Company will take appropriate security measures to ensure its confidentiality and integrity and to avoid undue disclosure or disclosure to third parties. The processing will be carried out by means of electronic media.

3. HOW HUAWEI SHARES PERSONAL DATA

For the purposes set out above, Huawei may disclose Personal Data to:

- Internal personnel, who have been given specific instructions on the security and correct use of Personal Data.
- In accordance with applicable data protection regulations, Huawei Group Company, including its parent company in China, in order to 2. perform some or all of the above purposes.
- 3. External subjects, such as e.g. the Tree S.r.l. agency, which Huawei uses for the pursuit of the purposes indicated above. In this case, these subjects will process the Personal Data as Data Processors pursuant to art. 28 of the GDPR. Please contact us to receive the updated list of service providers to whom Huawei discloses Personal Data.
- Where required by law, from time to time, to public bodies or judicial authorities.

Outside of these cases, Personal Data will not be disclosed.

Any communication of Personal Data under 3.2, could involve the transfer of Personal Data to countries outside the European Union (e.g. China). 4. PERIOD OF CONSERVATION OF PERSONAL DATA

The Personal Data collected for the purposes indicated, will be processed and stored for a period equal to the period in which Huawei will need to use the Personal Data based on the purposes indicated above, but not later than 24 months.

5. RIGHTS OF INTERESTED PARTIES

In accordance with the provisions of Chapter III, Section I of the GDPR, you may exercise the rights indicated therein:

- 1. Right of access to Personal Data (Article 15 GDPR);
- 2. Right to rectification of Personal Data (Article 16 GDPR);
- 3. Right to erasure of Personal Data (Article 17 GDPR);
- 4. Right to limitation of Personal Data (Article 18 GDPR);
- 5. Right to portability of Personal Data To receive personal data concerning you in a structured format, commonly used and readable by an automatic device, as well as to have them transmitted to another controller without hindrance (Article 20 GDPR);
- 6. Right to object Object to the processing of Personal Data, unless there are overriding legitimate grounds for Huawei to continue the processing (Article 21 GDPR);

You may exercise all of the rights listed above in the manner indicated on Huawei's website at www.huawei.com/en/personal-data-request or by sending a letter to the registered office of the Company referred to in paragraph 6 below.

If you believe that the Personal Data has not been processed in accordance with the law or there are disputes regarding its use, you can lodge a complaint with the Supervisory Authority of the Member State in which you reside, work, or the place where the alleged violation occurred.
