DIVERSITY DISCOUNT

We are a member of the International Franchise Association ("IFA") and participate in the IFA's DiversityFran® Program, which provides special financial incentives to minority communities. **Pursuant to this program, we reduce the total of the Franchise Fee by \$5,000 for all minority-owned and women-owned businesses.** To qualify for the Diversity Discount, the franchised business must be at least 51% owned by a woman or minority (i) who are also designated as the Key Person in the Franchise Agreement and (ii) otherwise meet our requirements to purchase a Franchised Business. This discount is for the first franchise only (first franchise of us or any of our affiliates). In determining whether an individual qualifies for the discount, we may be guided by the definitions used by applicable United States government offices, but the decision remains ours. As of the date of this FDD, we have adopted the definition of "minority" to mean Black Americans; Hispanic Americans; Native Americans; Asian Pacific Americans; Subcontinent Asian Americans; and members of other groups designated from time to time by the SBA."
